The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 605 of the Florida Statutes.

ARTICLE I - NAME


ARTICLE IX - ADOPTION OF OPERATING AGREEMENT

ARTICLE X - AMENDMENT


The Company shall have the power to amend or supplement these Articles of Organization when approved by majority vote of the Members.
