ARTICLES OF ORGANIZATION 55 OCEAN LANE 1018 LLC

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII ADDITIONAL MANAGERS
