**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is Konkreta QOZB, LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address office of the Company is 2980 NE 207th Street, Suite 409, Aventura, FL 33180.

**ARTICLE III. REGISTERED AGENT AND OFFICE**




**ARTICLE VI. PURPOSE**
