**ARTICLES OF ORGANIZATION  
OF  
TIME TRAVELER TRANSPORT, LLC**

**SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS**

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization to the Florida Department of State, Division of Corporations, in accordance with Chapter 605 Florida Revised Limited Liability Company Act (the *Act*).

**SECTION 2 NAME**

The name of the limited liability company is Time Traveler Transport, LLC, a Florida limited liability company (*Company*).

**SECTION 3 DURATION**

The Company will perpetually exist from the filing date of these Articles of Organization with the State of Florida, Division of Corporations of the State of Florida, unless dissolved according to law.

**SECTION 4 COMPANY'S PURPOSE**

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

**SECTION 5 COMPANY'S PRINCIPAL OFFICE AND LOCATION OF RECORDS**

**SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE**




