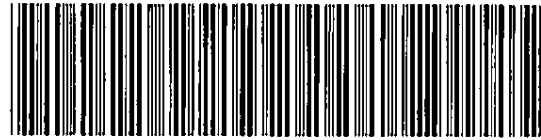

NAME**

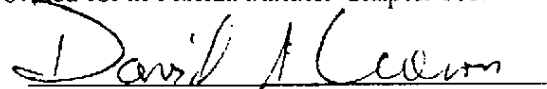
