ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Ch. 605, Florida Statutes, 2021).

ARTICLE I

NAME

The name of this limited liability company is **CJA SUNSET, LLC** (the "Company").

ARTICLE II

DURATION

The Company shall exist for indefinite duration in accordance from the date of filing these Articles of Organization with the Department of State until the occurrence of any of any of the events specified in Section 605.0701, Florida Statutes (2021), unless continued by the unanimous consent of all of the remaining members.

ARTICLE III
