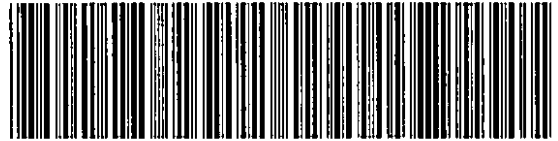

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be MURPHYS' MERCANTILE, LLC ("Company"). The principal place of business of the Company in Florida shall be 308 Dawson Brown Road, DeLeon Springs, Florida, 32180

ARTICLE II

DURATION

The Company shall commence its existence on December 8, 2021. The Company's existence shall continue in perpetuity.

ARTICLE III

PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in internet sales business and to transact any lawful business or activity authorized under Florida Statutes and in general to carry on any and all incidental business. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

#### ARTICLE IV

##### REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the state of Florida is Robert R. Foster, Esquire, 108 West Rich Avenue, DeLand, Florida 32720.

#### ARTICLE V

##### CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company the cash or property set forth as follows:

#### ARTICLE VI

##### ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company at such times and in such amounts as may be provided in the regulations adopted by the members or, in lieu thereof, only upon the unanimous consent of all the members.

#### ARTICLE VII

##### ADMISSION OF NEW MEMBERS (TRANSFERABILITY OF INTERESTS)

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the

management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

## ARTICLE VIII

### PROFITS AND LOSSES

A. Profits. After payment of the expenses of this limited liability company, each member shall be entitled to a distributive share of the profits of this limited liability company in accordance with an agreed upon formula or, in the absence of such formula, in proportion to each member's then outstanding contributed and not returned capital. The distributive share of the profits shall be determined and paid to the members by December 31st of each year.

B. Losses. Any losses which occur in the operation of this limited liability company shall be paid from the profits and capital of this limited liability company or, if the profits and capital are not sufficient to pay these losses, by the members in proportion to their capital accounts.

## ARTICLE IX

### TERMINATION OF EXISTENCE (CONTINUITY OF LIFE)

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member of the Company, unless the business of the Company is continued by the consent of a majority in interest of the remaining members, provided there is at least one (1) remaining member.

## ARTICLE X

### MANAGEMENT (MANAGEMENT BY MEMBERS)

The Company shall be managed by the members in accordance with regulations adopted

by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 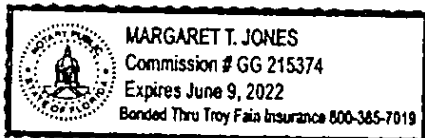
