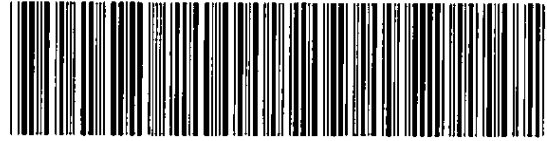

ARTICLE I - NAME

The name of the limited liability company shall be **CREIGHTON MHP, L.L.C.** ("Company").

ARTICLE II - ADDRESS

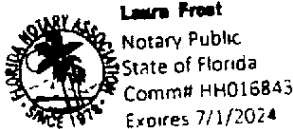

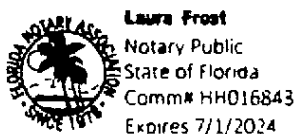
