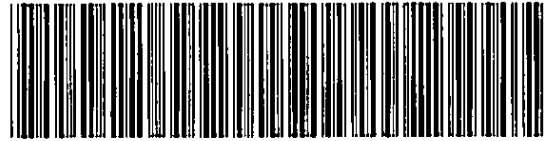



ARTICLE IV - MANAGEMENT




