The undersigned, JOSEPH E. ROLLINS JR., competent to contract and an authorized representative of ROLLINS FAMILY LLC, hereby presents these Articles of Organization as the Articles of Organization of ROLLINS FAMILY LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ROLLINS FAMILY LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


ARTICLE V - REGISTERED OFFICE AND AGENT


