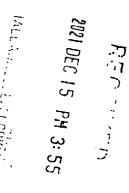

<u>ARTICLES OF ORGANIZATION</u>

SUMKING COLD STORAGE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be SUMKING COLD STORAGE, LLC. The street address of the principal office of the limited liability company in Florida shall be 1510 W. Sydney Road, Plant City, Florida 33566, and the mailing address shall be PO Box 4084, Plant City, Florida 33563.

ARTICLE II - DURATION

<u>ARTICLE III - PURPOSES AND POWERS</u>
