**ARTICLES OF ORGANIZATION

The undersigned, Price Rainer, a natural person competent to contract and an authorized representative of Sticks and Bricks, LLC, hereby presents these Articles of Organization as the Articles of Organization of Sticks and Bricks, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Sticks and Bricks, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS
