

The undersigned, acting as the authorized representative of Plutus Advisory Services, LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

**ARTICLE I: NAME**

The name of the Company shall be Plutus Advisory Services, LLC.

**ARTICLE II: ADDRESS AND PLACE OF BUSINESS**

The initial address of the principal office and the mailing address of the Company shall be 1511 N. Westshore Blvd, Suite 700, Tampa, Florida 33607.

**ARTICLE IV: MANAGEMENT**




