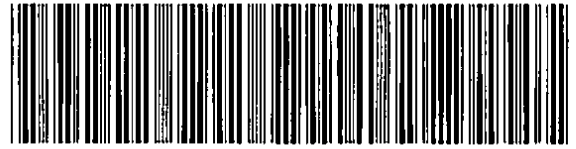

ARTICLE V - MANAGEMENT




