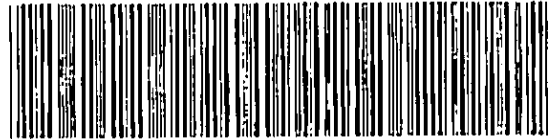

The Limited Liability Company's principal address is 100 Ashley Dr, Suite 600, Tampa, FL 33602.






