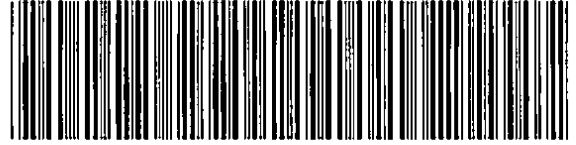

The name of the limited liability company shall be: India Amory, LLC.


