ARTICLE 1

Name

The Company is to be managed by one or more managers and is, therefore, a manager-managed limited liability company within the meaning of the Act. The initial manager of the Company is Luis H. Mozas.

ARTICLE 6
Purpose

The Company has been organized as a "qualified opportunity fund" for purposes of Sections 1400Z-1 and 1400Z-2 of the Internal Revenue Code of 1986, as amended (the "Code").
