

**ARTICLES OF DISSOLUTION

Article I - Name of Corporation

Article III - Approval of Dissolution


The dissolution was approved by the sole shareholder of the Corporation by written consent dated March 31, 1998, pursuant to Section 607.0704 of the Florida Statutes.
