**ARTICLES OF MERGER  
BETWEEN  
JO-V TOOLS, LCC, a Florida limited liability company  
AND  
JO-V TECHNOLOGIES, LLC, a Florida limited liability company**

Pursuant to Sections 605.1025, *Florida Statutes*, Jo-V Tools, LLC, a Florida limited liability company ("Surviving Entity") and Jo-V Technologies, LLC, a Florida limited liability company ("Merged Entity"), adopt the following Articles of Merger for the purpose of merging the Merged Entity into Surviving Entity, the latter of which is to survive the merger.

**ARTICLE I  
PLAN OF MERGER**

The Members and Managers of the Merged Entity and the Surviving Entity have adopted a Plan of Merger as required in Section 605.1022, *Florida Statutes*.

**ARTICLE II  
SURVIVING ENTITY**

The surviving entity shall be JO-V TOOLS, LLC, a Florida limited liability company.

**ARTICLE III  
ADOPTION REQUIREMENTS**

The attached Plan of Merger meets the requirements of Section 605.1022, *Florida Statutes*, and was adopted by the Manager and Members of the Merged Entity on December 21, 2021, and by the Manager and Members of the Surviving Entity, on December 21, 2021.

**ARTICLE IV  
APPRAISAL RIGHTS**

The Surviving Entity has agreed to pay to any member of either entity with appraisal rights the amount to which such members are entitled under the provisions of Section 605.1006 and 605.1061-605.1072.

**ARTICLE V  
NAME CHANGE**

The Surviving Entity will change its name to Jo-V Technologies, LLC. *The Merged Entity agrees that Surviving Entity may use the name Jo-V Technologies, LLC.*




