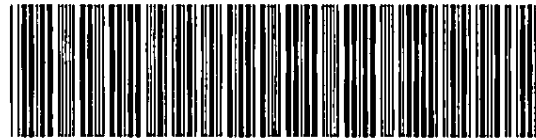



**AMENDMENT TO ARTICLES OF ORGANIZATION**





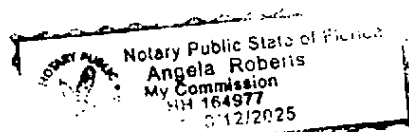
