

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION OF
SIFI INVESTMENTS, LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is SIFI INVESTMENTS, LLC (the "**Company**").

2. The date of filing of the Articles of Organization for the Company was January 4, 2022, and the Company was assigned document number L22000002260.

3. The sole member of the Company has adopted the following amendment to the Articles of Organization:
