Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of LE GERANT, LLC, are hereby amended as follows:

1. The name of the limited liability company is LE GERANT, LLC (the "Company").
2. The Articles of Organization of the Company were filed with the Florida Department of State on January 4, 2022, and the document number is L22000002981.
3. Article 5 of the Articles of Organization is hereby replaced with the following, to read in its entirety as follows:

"ARTICLE 5

Management of the Company

The Company is to be managed by one or more managers and is, therefore, a manager-managed limited liability company within the meaning of Section 605.0102(39) of the Act.
