**WHEREAS**, the Company was formed pursuant to the laws of the State of Florida on January 4, 2022 and assigned document number L22000003251; and

**WHEREAS**, the sole Member of the Company has recommended the amendment to the Articles of Organization set forth below; and

**WHEREAS**, the undersigned Company, by and through its Manager and sole Member and pursuant to the provisions of Section 605 of the Florida Statutes, amends the aforesaid Articles of Organization in the manner hereinafter set forth effective upon the filing of these Articles of Amendment;

**NOW, THEREFORE**, the undersigned hereby amends the Articles of Organization as follows:

1. Article IV of the Articles of Organization of the Company is hereby modified and restated as follows:

**ARTICLE IV**  
**MANAGEMENT**

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company is Brian P. Carolan who shall serve until replaced according to the provisions of the Company's Operating Agreement.

2. The date of the foregoing amendment's adoption was February 23, 2022.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
