Chafoulias, a natural person competent to contract and an authorized representative of THE FLIGHT EXCHANGE ADVISORS, LLC hereby presents these Articles of Organization as the Articles of Organization of THE FLIGHT EXCHANGE ADVISORS, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is THE FLIGHT EXCHANGE ADVISORS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


