**ARTICLES OF ORGANIZATION  
OF  
DOUBLE POND CAMPGROUND, LLC**

The undersigned, in order to form a for profit company and pursuant to Chapter 605, Florida Statutes, hereby adopt the following Limited Liability Company Articles of Organization:

**ARTICLE I  
Name and Principal Office**

The name of the limited liability company is **Double Pond Campground, LLC** (the "Company"). The principal office and mailing address shall be located at: **2152 Brown Road, Ponce de Leon, Florida 32455**.

**ARTICLE II  
Duration**

The Company shall have a perpetual duration.

**ARTICLE III  
Purpose**

The purposes for which the Company is formed is for the development, ownership, and operation of spaces/sites that provide for occupancy for one of the many types of recreational vehicles, including but not limited to pull behind campers, tent trailers, van conversions, fifth wheels, motorhomes, and bus conversions, that are set up for camping and other outdoor recreational purposes, and to further engage in any other lawful act or activity for which a limited liability company may be organized pursuant to the law.


**ARTICLE VIII**
