

ARTICLES OF ORGANIZATION OF DOUBLE POND CAMPGROUND, LLC

The undersigned, in order to form a for profit company and pursuant to Chapter 605, Florida Statutes, hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I Name and Principal Office

The name of the limited liability company is **Double Pond Campground**, **LLC** (the "Company"). The principal office and mailing address shall be located at: 2152 Brown Road, Ponce de Leon, Florida 32455.
