ARTICLES OF ORGANIZATION
OF

The undersigned acting as the organizer of 2525NOBT, LLC, under the Florida Limited Liability Company Act, Chapter 605, *Fla. Stat.*, adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is 2525NOBT, LLC (the "Company").

ARTICLE II - Address:

ARTICLE III - Duration:
