ARTICLES OF ORGANIZATION
OF

The undersigned acting as the organizer of FABRICATE FLORIDA, LLC, under the Florida Limited Liability Company Act, Chapter 605, *Fla. Stat.*, adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is FABRICATE FLORIDA, LLC (the "Company").

ARTICLE II - Address:

ARTICLE III - Duration:

ARTICLE IX - Effective Date:


In accordance with Florida Statutes §605.0207, the Company shall have an effective date of January 1, 2022.
