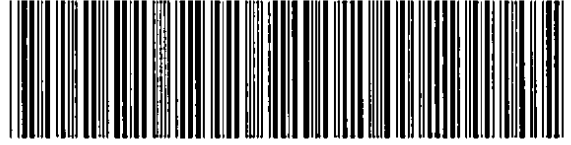

**ARTICLES OF ORGANIZATION FOR
11600 COURT OF PALMS 206, LLC,

ARTICLE VI - Members Rights to Continue Business






