**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
WINTER GARDEN FLEX LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **WINTER GARDEN FLEX LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is Winter Garden Flex LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on January 7, 2022, under Document Number L22000010189, as amended by Articles of Amendment to Articles of Organization of the Company filed with the Florida Department of State on December 22, 2022, and as further amended by Articles of Amendment to Articles of Organization of the Company filed with the Florida Department of State on January 19, 2024.


THIRD: The following amendment to the Articles of Organization was adopted by the Company:

Article IV of the Articles of Organization is hereby amended and restated in its entirety to read as follows:

"ARTICLE IV - MANAGEMENT

The Company shall be a manager-managed company. The sole manager of the Company is Winter Garden Flex Manager, LLC, a Florida limited liability company, 12200 West Colonial Drive, Suite 303, Winter Garden, Florida 34787."
