**ARTICLES OF ORGANIZATION
OF
LEVEL FACILITY SERVICES, LLC**

The undersigned, Christopher Reid, a natural person competent to contract and an authorized representative of Level Facility Services, LLC, hereby presents these Articles of Organization as the Articles of Organization of Level Facility Services, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Level Facility Services, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS
