**ARTICLES OF ORGANIZATION
OF
NORTH OLA, LLC**

The undersigned, acting as the organizer of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby forms a Florida limited liability company (this "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (these "Articles"):

**ARTICLE I
Name**

The name of this Company shall be: NORTH OLA, LLC

**ARTICLE II
Place of Business**

The principal place of business and mailing address of this Company shall be 301 W. Platt Street, #A62, Tampa, Florida 33606, and such other place or places as may be designated by the manager from time to time.

**ARTICLE III
Registered Agent and Office**

The initial registered agent for this Company shall be CHESTNUT BUSINESS SERVICES, LLC, and the address of the registered agent for service of process shall be 911 Chestnut Street, Clearwater, Florida 33755.

**ARTICLE IV
Membership Units**

This Company shall be authorized to issue One Thousand (1,000) membership interests, no par value, which shall be divided into two (2) classes: (i) 500 Class A Voting Membership Units, which shall be designated as "Voting Units," and (ii) 500 Class B Non-Voting Membership Units, which shall be designated as "Non-Voting Units." Each of the Voting Units shall entitle the holder thereof to one (1) vote at any meeting of the members. There shall be no other differences in the rights of such membership units.




