**ARTICLES OF ORGANIZATION**

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of BAYOU HOME APARTMENTS, LLC, a Florida limited liability company (the "Company").

**ARTICLE 1: NAME AND MAILING ADDRESS**

The name of this Company is BAYOU HOME APARTMENTS, LLC and its principal office is 220 Ocean Street, Jacksonville, FL 32202 and mailing address is P.O. Box 1020, Jacksonville, FL 32201.

**ARTICLE 2: DURATION**

The duration of the Company is perpetual, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

**ARTICLE 3: PURPOSE**

No member of the Company shall be an agent of the Company solely by virtue of being a member.

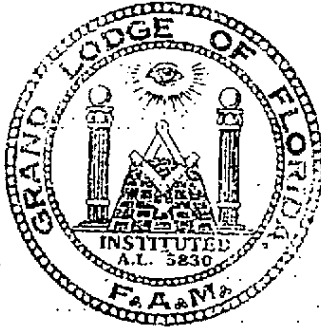
ARTICLE 7: OPERATING AGREEMENT
