**ARTICLES OF ORGANIZATION FOR
FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, David E. Hightower, a natural person licensed to practice law in Florida and the sole member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

ARTICLE I - Name

The name of the Professional Limited Liability Company is HLF II, PLLC.

ARTICLE II - Address
