AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION FOR  
SIP AND STYLE BLOWTQUE, LLC

The original Articles of Organization for SIP AND STYLE BLOWTQUE, LLC were filed on January 10, 2022, effective as of January 7, 2022, and assigned Florida Document Number L22000017837. Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned Florida limited liability company hereby amends and restates its Articles of Organization in their entirety and adopts the following Amended and Restated Articles of Organization in their place:

ARTICLE I

Name

The name of the Limited Liability Company shall be SIP AND STYLE BLOWTQUE, LLC.






