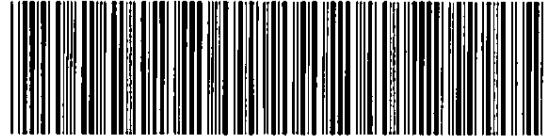



**ARTICLES OF CONVERSION
