ARTICLE I
NAME

The name of this Limited Liability Company is **Austin Ecological Consultants, LLC**

ARTICLE II
DURATION





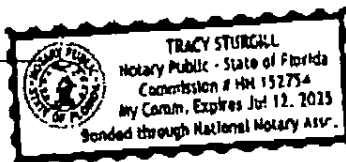
