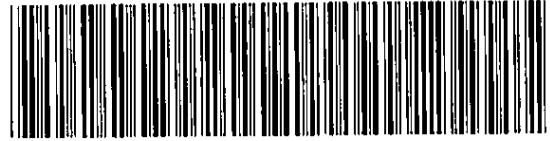



FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came before this Court upon the Petitioner's Amended Petition for Dissolution of Marriage, Partition of Real Property and Other Related Relief and the Court being advised in the premises, it is:

ORDERED AND ADJUDGED THAT:

1. This Court has jurisdiction over the parties and subject matter of this action, and that the bonds of marriage between the parties are hereby dissolved because the marriage is irretrievably broken and the Court enters its decree dissolving the marriage.

2. The Marital and Property Settlement Agreement and Basic Parenting Plan entered into by the parties on March 28, 2023 were executed freely and voluntarily by the parties, are in the best interest of the parties and the child and same is hereby approved, ratified, and incorporated into the Final Judgment of Dissolution of Marriage by reference as if fully written herein, and the parties are ordered to comply with it.

3. The parties shall exchange updated financial affidavits, supporting income information and any other documentation relevant to the recalculation of child support contemplated in the parties Marital Settlement Agreement within 30 days of the entry of this Final

Judgment of Dissolution of Marriage.

4. The Marital and Property Settlement Agreement and Basic Parenting Plan shall not be merged into this Final Judgment of Dissolution of Marriage, but rather shall survive it for all time.

5. The Wife's maiden name shall be restored and she shall now be known as RACHEL MARIE METCALFE.

6. The Court retains jurisdiction over the parties and this cause to enforce and modify the terms of the Final Judgment of Dissolution of Marriage and enter further orders the court deems just and proper.
