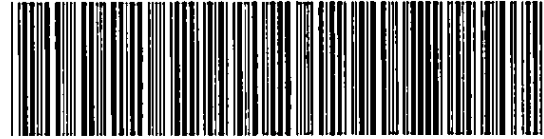



The Limited Liability Company is to be a manager-managed company.


