I received a confirmation that the payment was successful (please see attached), but the articles of organization never posted on SunBiz.

I then wrote an email asking about the status and I received a follow up email indicating that due to an error on SunBiz's end related to a new credit card processing system that the initial filing had not processed and I would need to refile the entity. That was on January 17, 2022. I refilled the entity on January 18, 2022.

I would like the original file date and effective date in December 2021 please.
