**ARTICLES OF ORGANIZATION
OF
GRGR LLC**

THE UNDERSIGNED certifies that the member has formed this limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, providing for the formation, rights, privileges and immunities of limited liability companies for profit.

ARTICLE I – NAME


