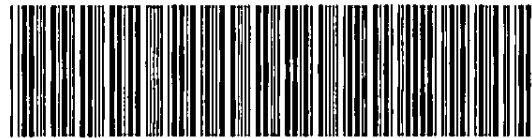

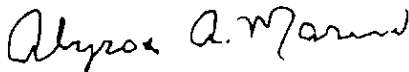

**ARTICLES OF ORGANIZATION OF  
GULF LIFE SWFL ISLAND TOURS AND SPORTFISHING, LLC**

To be Organized & Existing  
Under the Laws of the State of Florida

**ARTICLE I - Company Name:** The limited liability company (the "Company") name shall be: **GULF LIFE SWFL ISLAND TOURS AND SPORTFISHING, LLC.**

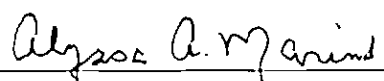
