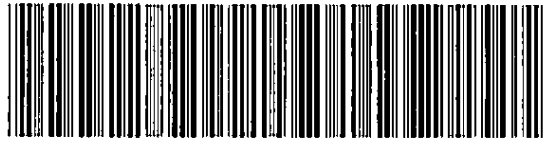

MEMBERS RIGHTS TO CONTINUE BUSINESS


The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a
