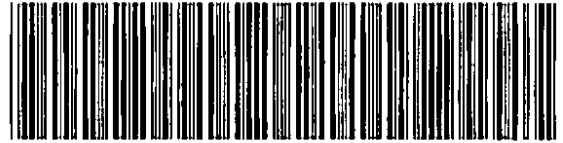

 The study aims to investigate the effects of a new educational program on student learning outcomes.
