DURATION**


The Company's existence shall commence on January 31, 2022, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

The Company shall be managed by one or more managers as provided in the Company's Operating Agreement and the initial manager of the Company shall be YONG SHAFER.


