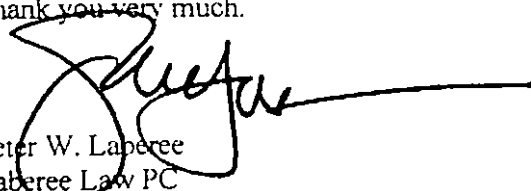

As a result, I wish to proceed with the conversion of SCT-NJ into a Florida entity by conversion.

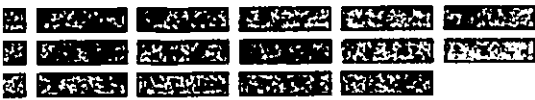

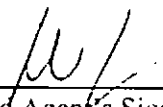

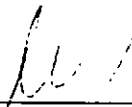
