**ARTICLES OF ORGANIZATION
OF
TLR DUMPSTERS, LLC**

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization to the Florida Department of State, Division of Corporations, in accordance with Chapter 605 Florida Revised Limited Liability Company Act (the *Act*).

SECTION 2 NAME

The name of the limited liability company is TLR Dumpsters, LLC, a Florida limited liability company (*Company*).

SECTION 3 DURATION

The Company will perpetually exist from the filing date of these Articles of Organization with the Florida Department of State, Division of Corporations, unless dissolved according to law.

SECTION 4 COMPANY'S PURPOSE

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.


SECTION 7 REGISTERED AGENT CONSENT

This Operating Agreement may be amended from time to time according to its provisions.


SECTION 12 MANAGEMENT
