(a) Manager's Unanimous Authority. 



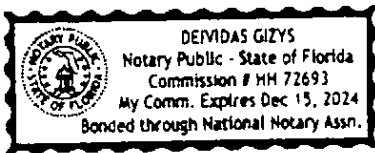
