AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF STEFAN MANN MD PLLC

In compliance with Chapter 605, Florida Statutes, and pursuant to the provisions of § 605.0202, and § 621.13(3) Florida Statutes, the following Amended and Restated Articles of Organization of Oak Concierge Medicine LLC, a Florida Limited Liability Company with its Articles of Organization filed under the name of Stefan Mann MD PLLC, with the office of the Florida Division of Corporations on the 26th day of January 2022, and assigned Florida document number L22000046045, is submitted. The LLC reserves the right to amend or repeal any provision contained in these Amended and Restated Articles of Organization, in the manner now or hereafter prescribed by statute, and all rights conferred upon a member herein are granted subject to this reservation.
