The name and address of the registered agent and office of the Company shall be Carmine Dell Aquila, 22220 Red Laurel Lane, Estero, FL 33928.



The Company's day to day business will be managed by its Members and is therefore a member-managed company. The initial member managers are Carmine Dell Aquila and Amy Dell Aquila.


